Entry Criteria

- i) Nominations can be received from anyone, providing the person being nominated meets the criteria.
- ii) The candidate must be recognised for the work done for an organisation in Keynsham or has benefited Keynsham in some way or must have made a significant contribution to the quality of life of those in Keynsham.
- iii) The nominator and seconder must not be a partner or relative of the candidate and cannot be a Keynsham Town Councillor or a member of Council staff.
- iv) The candidate must be nominated for voluntary work in the Town.
- v) Nomination forms (available from the Town Council office) to be received in the Town Council Offices by **Friday 28th February 2025**. Printed submissions must be returned to the Town Council Offices by this date.
- vi) Each application will be discussed at the March Town Council meeting and the winning recipients will be notified shortly thereafter via post.
- vii) The award will comprise of a framed A4 Certificate and £100 towards the citizen's chosen Keynsham group/project/cause/charity.
- viii) The awards will be given out at the Annual Town Council Meeting in April.
- ix) The winner of the Keynsham Good Citizen Award can be put forward for the B&NES Chairman's Community Awards.
