13. ANIMALS ARE NOT PRIZES

RECOMMENDATION:

To consider the correspondence below from a Keynsham resident received by Cllr Biddleston.

"Dear Councillor Biddleston,

As a concerned constituent and animal lover, I am writing to you today about the outdated practice of giving away pets - namely goldfish - as prizes.

While many believe this outdated practice belongs in history books and has no place in modern society, I was saddened to find out that this is still all too commonplace. In fact, according to a recent poll conducted by Savanta for the RSPCA, 86% of the British public were shocked to discover this piece of information, with 84% of people agreeing that local authorities should take action.

Across England and Wales each year, swathes of goldfish are sadly left hanging in unsuitable plastic bags at fairgrounds and fetes. Many of them are won by children or their parents, who are unprepared to take on a pet, simply as the result of winning a game. I'm sure you'll agree that pet ownership is a huge responsibility, and not one that should ever be prized off to the public.

As an animal lover, I feel strongly that more needs to be done to protect these animals, many of whom will sadly die before they actually reach their new homes. Goldfish are easily stressed and very often fish that are won as prizes suffer miserably from shock, oxygen starvation or from changes in water temperature.

As the summer season approaches and more public events take place, I am very worried about pets being given away on council owned land. This is bound to leave the wrong impression on the general public, and could have unwanted (and preventable) consequences for the animal. This is where I'm hoping you can help.

Local authorities have the opportunity to make meaningful changes by taking a stand against this practice on council-owned land.

While I understand that the practice of giving away pets as prizes, particularly goldfish, has long gone on and may bring enjoyment to some, acquiring an animal to be kept as a pet should be the result of careful planning and prior consideration. Additionally, action on this matter may also deter people from awarding other pets as prizes, protecting other popular pets such as dogs. Animals are big prizes that can come at an even bigger cost.

The RSPCA supports measures taken by local authorities to end this outdated practice on Council owned land, which will ensure their welfare and raise public awareness of the issue. I write to ask you to please work with the RSPCA who have drafted some suggested text for a motion. This could form the basis of a proposal to the local authority to take more action on this issue. It would be great if you could encourage your fellow councillors to pass a motion similar to this to improve animal welfare in this area. Moreover, the RSPCA's local government manifesto provides information and resource for you to take action locally to protect and promote animal welfare.

Further information regarding this campaign can be found in the RSPCA's briefing document for elected representatives here. The RSPCA launched a public campaign in 2021, with thousands of supporters taking action. A total of 36 local authorities in England and 12 in Wales have secured a ban so far, following the groundswell of support for this campaign. Will you please join them?

Please take action on behalf of animals and join the other local authorities in England and Wales that have already pledged to put a stop to this. Pets as prizes is a no-win situation for animals and their potential new owners."
