## 61. ROOFTOP REVOLUTION

Cllr Cannon reported that a meeting had taken place between himself, Cllr Wait, Olly Henman, Alistair Singleton (KCE), Charles Gerrish. There is a possibility that solar panels could be installed on the roof of the leisure centre, as KCE are finding it difficult to get the panels on the Riverside building.

Action agreed to contact the residents of Riverside and Cllr Wait was going to seek a list of residents.

63. BRISTOL EAST FRINGE CYCLE AND WALKING PATHS

James Boxall-Clasby updated the Committee that KAT had had a meeting in person which was successful.

It was reported that KAT are keen to see Somerdale site and the A4175 (Willsbridge Road) linked up with a cycle path, although concerned that the possibility of a route cutting through the overspill station carpark could cut through the off-road bike track, KAT supports the existence of both.

JBC posed some questions on the new cycle path development on the A4175; would the existing route remain accessible to active travel and not just pedestrians going forward, as the new route is less direct and likely to be prone to flooding. Also, will horse riders have access to the new route, will it be a designated bridal way.

It was reported that KAT supports E Bike hire provision in Keynsham to connect Keynsham to Bristol and Bath. *The Committee were reminded that unless Bristol and Bath used the same provider it wouldn't be feasible.* The Station would, in theory, be a good hub for these bikes.

Cllr Cannon reminded the Committee that although in principle E Bikes and Scooters were introduced to reduce the number of cars on the road, actually it means less people are walking and using these instead and therefore reducing the amount of exercise.

JBC summarised that KATs aim is to provide a consistent joined up network of routes for both existing and new users, that compliments the A4 but does not rely solely on it.

KAT are keen to be part of working groups to support with the E&S Plan.
