DTC gave verbal update on meetings with BANES and Counter Terrorism advisor.

To close the roads as per the structure of previous Winter Festivals would cost in the region of £4.5k.

Alternate locations and layouts were discussed to reduce the number of roads that need to be closed for the event.

RESOLVED:

i) 3 options to be taken to Full Council of a restructure of the Winter Festival:

Option 1: Use of Bath Hill East car park.

Option 2: Use of Ashton Way car park – closing Ashton Way to cars.

Option 3: A daytime event on Market Walk and Temple Street.

ii) A clear press release to the public explaining the reasons for the change to the Winter Festival.

17. WINTER FESTIVAL 2024

RESOLVED:

Prices to be increased for traders as per inflation.

18. CHRISTMAS IN JULY

RESOLVED:

DTC to decide on date, avoiding first and last weeks in July and 22nd July.

19. INTERPRETATION BOARD AT THE CEMETERY

This has evolved into a project consisting of a QR code at the Cemetery and potentially Somerdale and Memorial Gates, providing information on those fallen.

RESOLVED:


Committee confirmed that a Plein-Air event would be something that KTC would like to host and lead on. Ask for support from ArtSpace for contacts and promotion.
