7. CONFIRMATION OF MINUTES

RESOLVED:

That the Minutes of the Committee's meeting held on 15th March 2018 were confirmed as a true record and were signed by the Chairman.

8. <u>INSURANCE OF THE ALLOTMENT</u>

RECOMMENDATION TO THE FINANCE AND POLICY COMMITTEE:

That the Town Council DO NOT increase their portion of the rent payable to Mr H J Paget for lease of the allotment, by the sum of £364.00, to allow a reduction in the Allotment Association's contribution of rent by the same sum, giving them funds of £364.00 which they would then use to finance their third party liability insurance.

This decision was made by the Allotment Committee who took into consideration the for the following reasons:-

- The Allotment Association currently have a healthy bank balance of £7256.80
- Allotment holder rents have only increased by £3.00 per year, meaning the total amount payable for an allotment is £14.00, per annum. A sum which is far below other similar allotment sites.
- All allotments on the site are currently rented, with 2 further people on the waiting list, meaning income is at its maximum.

9. HALF-YEARLY REPORT – KEYNSHAM ALLOTMENT ASSOCIATION

A copy of the Allotment Association's half yearly report is attached.

Matters arising from the report:-

Treasurer's report.

In the minutes of the Allotment Committee dated 15th March 2018, a figure of approximately £9,000 was recorded as being the balance in the Association's bank account at the date of the AGM. However, the figure recorded today is £7256.80, £1743.20 less and expenditure is recorded as totalling £813.30. A question was asked as to where the other monies had been spent and a request was made that the details of this expenditure be emailed to the Deputy Town Clerk.

Site security

A question was asked about CCTV and it was reported that there is now a shared CCTV system in place that provides coverage of the main gate. This CCTV is wifi accessible by the owner of the CCTV (a neighbour to the Allotments) and the Allotment Association. Many of the allotment holders have now installed their own solar powered security lights.
